

FAYETTE COUNTY LEGISLATIVE BODY July 23, 2002

BE IT REMEMBERED That the Fayette County Legislative Body met in regular session at the Courthouse in Somerville, Tennessee, on the 23rd day of July, 2002.

Present and presiding the Honorable Jim Voss. Also present, Dell T. Graham, County Clerk, and the following County Commissioners: John W. Arnett, Floyd Bonner, Charles Dudley Brewer, Sr., Joe B. Sullivan, Sr., Rhea "Skip" Taylor, Gordon M. Tomlin and Myles Wilson.

Absent: Wayne Thomas.

With a quorum being present, the following proceedings were had and entered of record, to-wit:

Motion was made by Commissioner Kelley, seconded by Commissioner Brewer and unanimously carried by the Board approving the minutes of the June 2002 meeting.

Motion was made by Commissioner Graves, seconded by Commissioner Doyle and unanimously carried by the Board appointing the following as Notaries Public: Sue Allen, Michelle B. Burnette, Shannon S. Cotter, Sue W. Culver, Cynthia L. Hubbard, James F. Lofties, Stephanie Skelton, Phyllis K. Springer, Lisa Teague, Betty C. Whitaker and Julia Yager.

The matter now before the Board was the election of members to the Fayette County Board of Public Works to serve two year terms.

SEAT NO. 1: Civil Districts 1, 2 and 3

Motion was made by Commissioner Harris placing the name of Charles Dacus as a nominee for election to the Board of Public Works. Motion was then made by Commissioner Taylor that the nominations cease. Motion was made by Commissioner Moore, seconded by Commissioner Doyle and unanimously carried by the Board electing Mr. Dacus by acclamation.

SEAT NO. 2: Civil Districts 4, 5 and 6

> Motion was made by Commissioner Brewer nominating Ezell Williams. Commissioner Bonner addressed the Board supporting Mr. Williams.

Upon r_011 call vote, the following votes were taken for PATTAT: Commissioners Burnette, Doyle, Graves, German, Harris, Logan, Moore, Morris, Sullivan, Taylor and Tomlin. (11)

Voting for WILLIAMS: Commissioners Arnett, Bonner, Brewer, Cox, Kelley, Morman and Wilson. (7)

Absent: Commissioner Thomas.

Thereupon, ROD PATTAT was elected to serve a two year term..

SEAT 3: Civil Districts 7, 8 and 9

Motion was made by Commissioner Kelley nominating Jim Goodman for election to the Board of Public Works. With no other nominations being offered, motion was made by Commissioner Tomlin and unanimously carried by the Board that the nominations cease and that Mr. Goodman be elected by acclamation.

Thereupon, JIM GOODMAN was elected to the Board of Public Works to serve a two year term.

SEAT 4: Civil Districts 10, 11 and 12

Motion was made by Commissioner Morris placing the name of Russell Wicker in nomination for election. With no other nominations being offered, motion was made by Commissioner Burnette and unanimously carried by the Board that the nominations cease and that Mr. Wicker be elected by acclamation.

Thereupon, RUSSELL WICKER was elected to serve a two year term on the Board of Public Works.

SEAT 5: Civil Districts 13, 14 and 15

Motion was made by Commissioner Sullivan nominating Steve Reeves for election to the Board of Public Works. With no other nominations being offered, motion was made by Commissioner Sullivan and unanimously carried by the Board that the nominations cease and that Mr. Reeves be elected by acclamation.

Thereupon, STEVE REEVES was elected to the Board of Public Works to serve a two year term.

Annual Financial Reports for the Clerk & Master, County Clerk, Circuit Court, General Sessions, Trustee, Register of Deeds, Sheriff and Juvenile Court were filed.

No reports from the Mayor's Office, Board of Education and Board of Public Works.

A written report from the Sheriff's Department was filed.

The report of Errors and Double Assessments and the report of Delinquent Real and Personnal & Public Utility Taxes was filed.

Commissioner Morris reported for the County Development Committee presenting their recommendation to contract with the State Planning Office for planning assistance with employment of a full time planner in the Office of Planning and Development. Commissioner Morris put this recommendation in the form of a motion, with a second being made by Commissioner Doyle. Said motion was unanimously carried by the Board.

No report from the Criminal Justice & Public Safety Committee.

Commissioner Tomlin reported orally for the Health & Welfare Committee.

No reports from the Personnel Committee, Education Committee and the Budget Committee.

With no other matters brought before this Board, said meeting adjourned.
