HOW TO OBTAIN A BUILDING PERMIT IN FAYETTE COUNTY (UNINCORPORATED)

1 - You must have an approved septic permit before obtaining a building permit.

A septic permit may be obtained by filling out an application online through the state of TN website (see attached for contact information).

2 - You must have an approved building permit application before obtaining a building permit.

To speed up the application process, please have your property visibly marked at the road with an address or name and have the proposed location of the dwelling marked with either flags or visible stakes.

3 - If constructing a home, you must have an approved plans review before obtaining a building permit. Please ensure your plans show the heated and unheated square footage as well as all plumbing fixtures.

IMPORTANT: NO CONSTRUCTION CAN BE STARTED UNTIL A BUILDING PERMIT HAS BEEN ISSUED

As the building permit is issued, you will pay two fees.

- 1 Adequate Facilities Tax This tax is \$0.99 per heated square foot on residential buildings and \$0.25 per total square foot under roof on commercial buildings. Your check or money order should be made payable to the Fayette County Trustee.
- 2 Building Permit Building permit fees for houses are calculated as follows: \$0.20 per heated square foot, \$0.10 per unheated square foot and \$10.00 per plumbing fixture, with a minimum building permit fee of \$50.00 and a minimum plumbing permit fee of \$20.00. We do not retain house plans. Building permit fees for mobile homes are as follows: \$100.00 for a single wide, \$200.00 for a double wide and \$300.00 for a triple wide. The following information is required for a mobile home permit: size, year, cost, and number of bedrooms/bathrooms. Commercial permit fees are based on \$5.00 per \$1000.00 of the contract price. A copy of the signed contract is required, and the permit must be pulled by a commercial contractor. Your check or money order should be made payable to the Fayette County Planning Office.

Our permits cover everything **except your electrical work**. You must pull all electrical permits through the state and have the state electrical inspector perform all electric inspections. You may contact Lan Mark Plumbing & Electrical Supply at 901-465-5078 for assistance in pulling your electrical permit.

Letters -

We require an engineer letter on monolithic slabs and block foundations 5 blocks or more.

An engineer letter may be required on other building components at the request of the Building Official.

You must have your building pretreated for termites and submit the termite pretreat letter to our office.

Both the engineer letter and the termite pretreat letter must be in your file in the office before we can perform a framing inspection. It is up to you or your builder to make sure we have the correct paperwork on file.

In the event that a customer would rather fill out a paper application please have them mail the application with payment to: Jackson Field Office 1625 Hollywood Drive Jackson, TN. 38305. However, please be advised that after we receive any paper applications we are then required to go online and submit their application through the system that is listed above.

All applications now must be processed through our online system. Therefore, we do encourage everyone to use the online system. We are more than willing to help with this service.
